



CALL FOR NON-EU INTERNATIONAL MOBILITY A.Y. 2025/2026 FAQs

1. I am interested in the non-EU Call but also in other mobility programs (e.g., Erasmus+). Can I submit multiple applications and receive both financial contributions?

Yes, provided that the exchange periods do not overlap. In any case, possible incompatibilities between different grants should be checked in the relevant Announcements.

2. I have just graduated from a Bachelor's degree programme and am not yet enrolled in a Master's degree programme. Can I apply?

Yes, but you must first proceed to enrol in the Master's degree course. In order to authenticate yourself in the TURUL application you must be enrolled at the university.

3. If I win an exchange spot but I finally decide not to accept it (or to renounce the exchange spot after accepting it) can I reapply the following year

Yes, there are no limitations or penalties against those who have applied for previous non-EU Calls.

4. I'm currently abroad (i.e. spending an Erasmus+ mobility), can I apply to the non-EU call for selection?

Absolutely, the application can be filled out entirely online by logging on to <https://ammissioni.unifi.it/ENTER/>

5. Do I need to be in possession of a language proficiency certificate in order to apply?

As indicated in Art. 5.1, knowledge of at least one foreign language certified by a certification (except for the cases of exemption from certification indicated in Annex 2) is a mandatory condition for applying to this Call. Applicants may indicate all the languages they know and have certified, but they may only select destinations whose linguistic requirements include the certified language(s), regardless of the CEFR (Common European Framework of Reference for Languages) level possessed. The language level required by the venues may be acquired at a later date, within the deadlines set by the destination itself for sending the required documentation to the successful students (see art. 6.2). The languages required by each University abroad can be viewed at <https://ammissioni.unifi.it/DESTINATION/>. Moreover, for the purposes of the online application to the UNIFI call for applications, if more than one language is indicated for a destination, knowledge of one of the indicated languages is sufficient. The knowledge of the foreign language(s) self-declared by the candidate in TURUL must be possessed at the time of completing the online application in TURUL. The self-declaration of language and level presupposes that

certificate issued by an appropriate external certifying body, certifying that he has passed a language proficiency test (please note, mere certificates of attendance are not pag. 1 Unità di processo Internazionalizzazione – Mobilità internazionale considered valid!). Recognised language certificates are listed in Attachment 1; certifications other than those listed in Attachment 1 may possibly be evaluated for ranking purposes

or

✓ The candidate falls in one of the certification exemption cases, listed in Appendix 2 to this Call ✓ For the purposes of this notice, it is emphasised that certifications from certifying bodies and the CLA are taken into consideration regardless of the date on which they were obtained. N.B. In the TURUL application, you are not required to enclose your certificate of language knowledge and declared level. However, you must be in possession, at the time of your application, of the certificate corresponding to the declared language and level, as required by the self-certification institution, and present it to the Offices if requested. If you have passed language tests at the CLA, you do not need to be in possession of the certificate: the Office will carry out the necessary checks directly with the CLA.

6. I am in possession of a certificate of knowledge of a foreign language required by the foreign Institution but not yet of the specific certification and/or level of language proficiency required by the university where I would like to spend the mobility. Can I submit the application?

Yes. The level or type of certificate required by the partner universities does not have to be possessed at the time of application to UNIFI, but must be acquired before departure or within the deadlines and according to the procedures set by the partner itself (see Announcement Art. 6).

7. I am not in possession of any language certificate. Can I submit my application?

If you are not in one of the exemption cases provided for in Annex 2 to the call for applications, you must be in possession of an attestation of knowledge of the language required by the destination(s) indicated among the preferences. To book a test, you can contact the University Language Centre CLA, and take the test within the deadline of the call for applications.

8. Who can I contact for information about the announcement?

For any information about the related to this Call for Applications, you can:

9. How can I identify the destinations to be indicated among the preferences?

In order to correctly indicate the preferred destinations, you must refer to the code (LINK) that uniquely identifies the mobility stream.

By connecting to <https://ammissioni.unifi.it/DESTINATION/> you can check all the in-force agreements between UNIFI and the Non-EU Partner Universities by selecting the menu 'International Mobility Non-EU Countries'.

Using the appropriate filters, you can select the in-force agreements by country and/or School. Once identified the agreement or agreements you are interested in, we suggest you mark down the code (LINK) because you need to specify it when choosing your preferred destination.

For each destination it is important to:

- check the ISCED code that identifies the study area covered by the agreement. Attached to the Announcement you find the ISCED codes description;
- read the section "Institution Notes";
- read the section "Notes".

10. What is the difference between a WINNING student and an ELIGIBLE student in the ranking?

For the purposes of the ranking, a 'winning' student is the student who has been allocated a destination; an 'eligible' student is the student who has not been assigned with a destination.

11. I have already closed the application but would like to make some changes. How can I do?

Within the deadline of the call for applications, send a request to the Help desk of the Turul application <https://ammissioni.unifi.it> via the "Request assistance" command, asking for your application to be reopened. After making any additions you deem appropriate, you must proceed again to close and submit your application and fill in the learning agreement and close it.

note: Help Desk assistance service will be active until March 4, 2025, 1.00 pm

12. I am a student enrolled in a third-cycle course, which degree should I declare?

You must self-declare your Master's degree. For those enrolled in a Post-graduate first level Master's degree, you must self-declare your three-year degree.

13. During my stay at the partner university, can I return to Florence to take an exam?

Yes. It is possible to temporarily return to Florence to sit an exam, provided that this does not compromise the successful completion of the study programme agreed in the *Learning Agreement* and that this does not represent a cost for the University.

14. Can I get a higher score if I decide to fill in the field 'motivation for the mobility' in the language of the destination country?

There is no additional score specified within the Announcement, if you fill in the motivation in the language

of the destination country.

15. I have already benefitted from a scholarship for non-EU international mobility, can I still apply for the same kind of mobility, or should I change its purpose, as for example for thesis research work?

It is possible to submit a second application with the same purposes.
